With reference to the above subject, the proposal for laying of Underground drainage line of 800mm dia across the road at Km: 3.450 of NH 275K Mysuru outer ring for total length of 45.00mtrs was sought by the Assistant Executive Engineer, UGD no.2 sub division, Mysuru. The proposal was examined by the Assistant Executive engineer, NH sub division, Mysuru and submitted to obtain the NOC permission vide letter under ref(1) above.


On examination of the proposal in light with the Ministry Circular no: RW/NH-33044/29/2015/S&R® dated: 22.11.2016, letter was communicated to the User department vide this office letter under ref (2) above to furnish the Licensee fee of Rs. 59,400 in the form of DD in favor of RPAO, Bangalore and Performance Bank Guarantee of Rs. 22,500.00 at the rate of Rs. 500/ rmt in the name of Executive Engineer, NH division, Bangalore.

Accordingly, the Assistant Executive Engineer, UGD no.2 sub division, Mysuru vide letter under ref (3) above, has submitted the Rs. 59,400 in the form of DD in favor of RPAO, Bangalore and Performance Bank Guarantee of Rs. 22,500.00 vide no: 58/2018-19 dated: 13.11.2018 valid up to 12.11.2019. Further, the AEE, UGD no.2 sub division, Mysuru has informed that currently old UGD line of 450mm dia has been installed from Hebbal 1st stage i.e Abhishek Circle to Infosys wet well via across Madegowda Circle, Outer ring road NH-275K & Skanray Technologies. Since the region is thickly populated, the exiting UGD pipe of 450mm dia is not able to carry the discharge resulting in leakage of UGD water thus traversing and reaching the Hebbal Lake. Hence, it is proposed to lay UGD pipe of 800mm dia .

Thus, the proposal is here with submitted with 2 set of Original draft agreement as per Ministry Circular no: RW/NH-33044/29/2015/S&R® dated: 22.11.2016 along with check list, drawings with ROW markings for obtaining concurrence from the Competent Authority.
