The SE, NHC, B'lore letter No.1336-37 Dtd:-24.09.2018. ******* M/s GAIL (India) Ltd, Bangalore in their letter dtd:08.09.2018 has sought NOC for laying of 100mm dia gas pipe line using trenching method along NH-234 from km 274.20 to 278.30 RHS of Huliyar-Sira section. The proposal received has been examined by State PWD(NH) with respect to Ministry's latest guide line vide No RW/NH-33044/29/2015/S&R(R) Dated D 22.11.2016. The firm proposed to lay the gas pipeline at 7.50mtrs to 15.00 mtrs away from the existing centre line of the Highway by open trench method. A strip plan indicating the proposed gas pipeline is also here with enclosed. The request of the firm to issue NOC for laying OFC cable is recommended here with subject to the following conditions. 1. The OFC has to be invariably laid at a minimum distance of 15mtrs from the centre line of existing Highway. If the ROW is at a distance more than 15mtrs then OFC has to be laid at the edge of ROW. 2. While laying cable the guide lines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) Dated 22.11.2016.

- 3. In case of any future development by widening to 4/6lane the firm shall be replaced/shift the laid cables at their own cost within reasonable time of intimation given by the Highway Authority.
- 4. The approval may be communicated from NH point of view.
