
3. In view of the above, the comments of public are invited on captioned proposal and the same should reach to below mentioned address till 24.02.2019 beyond which no comments will be considered.

Sir,

The cited proposal was received by this office vide MoRTH, RO-Ranchi letter dated 03.05.2018 [ref. (i)] for examine the case in accordance with Ministry's guidelines dated 22.11.2016.

2. After scrutiny, the proposal was returned to BSNL vide this office letter dated 25.05.2018 with certain observations for compliance of the same & re-submission of proposal.
3. After compliance of observations, BSNL has re-submitted their proposal to this office vide letter dated 28.06.2018 [ref. (iii)]. However, the desired Bank Guarantee & License fee was not submitted with the proposal. Accordingly, this office vide letter dated 14.08.2018 [ref. (iv)] requested BSNL for submission of same.
4. The desired Bank Guarantee for an amount of Rs. 32,89,700/- (Rupees thirty two lacs eighty nine thousand seven hundred only) has been submitted by BSNL vide letter dated 28.09.2018 [ref. (v)] and desired License Fee for an amount of Rs. 3,46,179/- (Rupees three lacs forty six thousand one hundred seventy nine only) has been submitted by BSNL vide letter dated 01.01.2019 [ref. (vi)].

The cited proposal has been scrutinized by this office as per MoRTH circular dated 22.11.2016 & found in order. Accordingly, the said proposal is hereby recommended for according necessary permission for laying of OFC for 34.351 Km between Bokaro to Peterwar on NH-23.
