



Please refer to your letter no. 468/Lalmatia dated 09.07.2018 vide which the proposal of permission for construction of Over Head Crossing of NH-80 of 132 KV D/C 2 Phase Sahibganj - Karamtola Transmission Line in between loc. AP 9/0 to AP 10/0. The proposal was sent to PD, NHAI, Sahibganj vide letter no.RW/Ranchi/OFC/21/2018-19/JHR/298 dated 18.07.2018. Further PD, NHAI has recommended the proposal vide letter no. NHAI/PD/PIU/SBG/NH-80/346 dated 12.10.2018.

2. In this regard, as observed in checklist enclosed with the proposal, the ground clearance has been proposed to be 8.9 m (mentioned at serial no. 58). Whereas, the clearance under maximum sag condition has been mentioned as 13 m at sr. no. 65. Accordingly, the proposed ground clearance needs to be clarified. Further, drawing submitted along with the proposal is not legible.

3. In view of the above, it is requested to kindly resubmit the duly filled checklist after verifying the same and making necessary compliance along with legible copy of drawing at earliest.
