The firm M/s. MY OWN ECO ENERGY Pvt Ltd., Kolar District has requested to permission to construct retail outlet and Access permission for approach road to proposed Bio fuel station abutting NH-219 at Km 97/010 (RHS) of NH-42 (Old NH-219) of Palamaner Krishnagiri road at Panthanahalli Village, Bangarpet Mandal, Kolar District, Karnataka and submitted the receipt of the Payment made towards processing fee for Rs.10,000/- on online vide Ref.No.0701190003990 dt:07.01.2019, issued by bharatkosh.gov.in. a Gol portal. The proposal is furnished with the following observations.

There are two intersections with Rural Roads/Approach Roads to private and public properties within 300 mts from the proposed retail outlet. As per MoRTH Guidelines No.RW/NH-33023/19/99-DD-III dt:24.07.2013, the approach road should be 300 mts away from the proposed fuel station. Hence, the dealer is requesting for relaxation to these deviation by considering the low traffic movement in these village roads.

The MoRTH vide Lr.dt.16.03.2016 has issued guidelines of relaxation from the Ministry's norms stipulated in circular dt.24.07.2013.

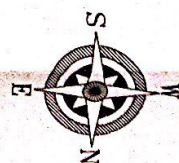
