Dinesh Engineers Ltd. is IP-1 License Holder, issued by the Department of Telecommunication and IT, Central Government of India. Under the provision the license which entitles us to lay underground OFC for digital India

We are planning to lay Optical Fiber Cable through duct adopting like HDD (Horizontal Directional Drilling) & Open Trench method as required on the ground to construct a fiber optical backbone link.

Since we are intending to lay the duct using HDD method, there will be minimum excavation or damage to the landscape along the road. We shall take care to minimize inconvenience to public and traffic during HDD/Trenching & reinstatement works. We will dig pits (size 1.5m x 1.0m) at the span of 150 to 250mtrs. Intervals to carry out the work.

We request you to grant permission to carryout above work as per your guidelines and conditions. Kindly issue the demand note accordingly. We trust, the proposal will receive your support. To support our application we are attaching the route drawing
