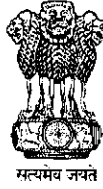

In inviting reference to above cites subject, it is to intimate that, IDCO has requested for grant of access permission for laying of 250 mm dia D.I. pipe along NH-57 from chainage 287.3 km to 296.2 km (8.9 Km.) with relevant documents.

The same is submitted herewith in shape of Bank Drafts amounting to Rs.5,68,692.00 + Rs.9,00,000.00 + Rs.9,00,000.00=Rs.23,68,692.00, bearing Nos.151605, 151604 & 151603 dtd.04.12.2018, respectively. - enclosed in original -
