Subject: Permission Proposal for Laying of UGSS Sewer pipeline along the NH from Km 633/100 - 636/330 (RHS) and across at Km 635/910 of NH-47 in the State of Tamil Nadu - Regarding.

The proposal is seeking permission by Executive Engineer, TWAD, Sewerage Division, Nagercoil for laying of UGSS Sewer pipeline along the NH from Km 633/100 - 636/330 (RHS) and across at Km 635/910 of NH-47 of NH-47. The SE, NH Tirunelveli vide letter No.1131/2018/JDO/ dated 11.08.2018 (received in this office 16.08.2018) has submitted the proposal to this office in accordance with Ministry's latest guidelines dated 22.11.2016.

2. The alignment proposed by the Executive Engineer, TWAD, Sewerage Division, Nagercoil for laying of UGSS Sewer pipeline along the NH from Km 633/100 - 636/330 (RHS) and across at Km 635/910 of NH-47 of NH-47 i.e. in a length of 3230m as detailed under:

- 3. The right of way is varies 9.30 to 31.70m in the aforesaid stretch. The Executive Engineer, TWAD, Sewerage Division, Nagercoil has proposed to lay the UGSS Sewer pipeline at the edge of the ROW for a length of 3230m. However, in the entire length of 3230m the underground Sewerage pipeline is proposed to be laid at a distance less than 15m which is not in conformity with Ministry's guidelines vide letter No.NHIII/P/66/76 dated 19.11.1976. Further Executive Engineer, TWAD, Sewerage Division, Nagercoil has mentioned that the UGSS Sewer pipeline is proposed to lay by using *Trench* where the distance is less than 15m from the center line of the carriageway and using HDD method across at Km 635/910 the NH at a depth of 2.45m from the bottom of the road.
- 4. The Executive Engineer, TWAD, Sewerage Division, Nagercoil has furnished an undertaking mentioning that they undertake to shift the UGSS Sewer pipeline if required by NH wing of State Highways Department/MoRTH Govt. of India at any time for expansion of the road at their own cost. Further it is also mentioned by TWAD that the proposed UGSS Sewer pipeline work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
- 5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
