S.H:- Proposal submitted by M/s GAIL Gas Limited for Seeking Permission/NOC for laying of 8" diaSteel Pipeline along the road from Km.187+500 to Km.188+325 of NH-72 (LHS) and from Km.216+100 to Km216+600 (RHS) of NH-58 &1 Crossing at Km 216+100 & 1 Crossing at Km.216+600 of NH-58 for a total length of 1325m by HDD method-reg.

The proposal is regarding permission for laying of a Public Utility "City Gas Distribution (CGD)" Steel Gas Pipeline of 8"NB along the road from Km.187+500 to Km.188+325 of NH-72 (LHS) and from Km.216+100 to Km216+600 (RHS) of NH-58 & 1 Crossing at Km 216+100 & 1 Crossing at Km.216+600 of NH-58for a total length of 1325m by HDD method in the State of Uttarakhand submitted to this office by PD, PIU-Vasant Viharvide letter no. NHAI/PIU-VSNT VHR/Retail Outlet/2021/2029dt. 28.03.2022.(Copy enclosed with checklist).

- 3. The Pipeline would be laid in the proposed alignment by Horizontal Direction Drilling (HDD) Methodology at a higher depth of 4 to 5 meter against the Ministry Stipulation of minimum 1.20m below the Ground Level.
- 4. Crossing Proposed by trenchless method with encasing for the entire width of NH. The encasing pipe will be laid at 4-5m below top of subgradeagainst Ministry Stipulation of minimum 1.20 meter below the top of the subgrade.
- 5. As per MoRTH Guidelines no. RW/NH-33044/29/2015S&R(R) dated 22.11.2016, the Highway Administrator will make available the subject proposal for 30 days in the public domain for seeking public comments/objections (on the ground of public inconvenience, safety and general public interest).

- The said proposal has been got examined through the assigned Supervision Consultant, M/s Chaitanya Projects Consultancy Pvt. Ltd for all aspects in totality i.e. site conditions and drawings in commensurate to ministry norms and thereby to this effect, supervision consultant submitted that the proposal as submitted is generally in order vide their letter no. CPC-MAV/TL/NHAI/NH-58&72/2020-21/1166 dt. 15.02.2022.
- Subsequently, the said proposal has been further examined in this office as per MoRT&H Guidelines/Norms for access permission to the proposed Retail Outlet issued vide letter no. RW/NH-33044/29/2015-S&R(R) dated 22.11.2016, RW/NH-33032/01/2017-S&R(R) dated 26.06.2020 & RW/NH/33032/01/2017-S&R(R) dt. 28.01.2021. - 4. In view of Methodology of laying of Steel Pipeline proposed by applicant, as a measure of abundant precaution against future settlement and other ailed problems, only selected granular material will be used in filing re-instatement of trench. The entire depth of cutting will be filled either with coarse sand or with the excavated material. The applicant shall get approval from NHAI for approval of fill material for better compaction before execution of this activity.
- 5. As per Ministry's guidelines issued vide circular No. RW/NH-33044/29/2015-S&R(R) dated 22.11.2016, charges for granting licence for use of Highway land and Performance Bank Guarantee for an amount based on per route meter with a validity of one year initially shall have to be furnished by the utility service provider. The details as per given below-
- i) License Fee for 05 years of **Rs.6,64,191/-** towards provisional permission as per policy guidelines dated 22.11.2016.
- (ii) Performance Bank Guarantee for an amount of Rs.1,44,500/- valid for a period of 01 year + 03 months initially (to allow suitable time for verification of BG and other administrative proceeding for approval) as per policy guidelines dt. 22.11.2016).
- 6. Above mentioned, License Fee & Performance Bank Guarantee has been calculated as per Ministry's guidelines issued vide circular No. RW/NH-33044/29/2015-S&R(R) dated 22.11.2016 & found to be correct.

In view of above, the subject proposal is herewith recommended for In-Principle approval from Highway Administration in accordance with the Ministry's guidelines. The said proposal is attached herewith in 04 sets (02 original +02 Copy) for kind perusal and approval please.
