- 2. The Right of Way in the stretch of NH proposed for laying Sewer pipe line is varying from 17.40m to 32.00m. The carriageway width of stretch from Km 65/457-65/532(LHS),Km 65/568-65/624(RHS) Km 65/871-66/063(RHS),Km 66/100-66/211(LHS),Km 66/390-66/635(LHS), Km 66/850-66/991(RHS),Km 66/915-69/300(LHS) of NH-234 both side aforesaid is 10.00 to 14.00m. The Executive Engineer, UGSS/Vellore City Municipal Corporation, Vellore has proposed to lay the underground Public Utility at edge of the ROW for a length of 3205m by adopting open trench method along the National Highway and HDD method across at Km 65/532, Km 65/723, Km 65/787, Km 65/871, Km 66/170,Km 66/291,Km 66/407, Km 66/665, Km 66/800 and 66/915 the National Highway.
- 3. The Executive Engineer, UGSS/Vellore City Municipal Corporation, Vellore has furnished an undertaking to the effect that they will remove the laid Public Utility sewer pipe line in future if required by NH wing of State Highways Department, Tamil Nadu/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Executive Engineer, UGSS/Vellore City Municipal Corporation, Vellore will also restore the ROW surfaces to its original condition soon after removal of the Public utility sewer pipe lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
