With reference to the subject cited above, the Assistant Executive Engineer National Highway Sub Division, Tumkur has submitted the proposals for obtaining Permission for laying of Underground 12" Steel Gas Pipe line along NH-234 (Huliyar-Sira section) from Km 290.200 to Km.277.00 in the state of Karnataka for a total length of 12.70 km on LHS of national Highway.

Hence the proposal is herewith submitting for issue of NOC with the following conditions for further needful.

1. Laying of 12" Steel Gas pipe line must be at the outer edge of the ROW on LHS of the existing ROW at a minimum depth of 1.50 m.
2. The trench should be filled up properly as per specifications & MORT&H norms and instruction of National Highway staff.
3. In case of any future development by widening to 4/6 lane the firm should give an under taking in bond paper that the laid 12" Steel Gas pipe line shall be replaced/shifted at their own cost within reasonable time of intimation given by Highway authority.

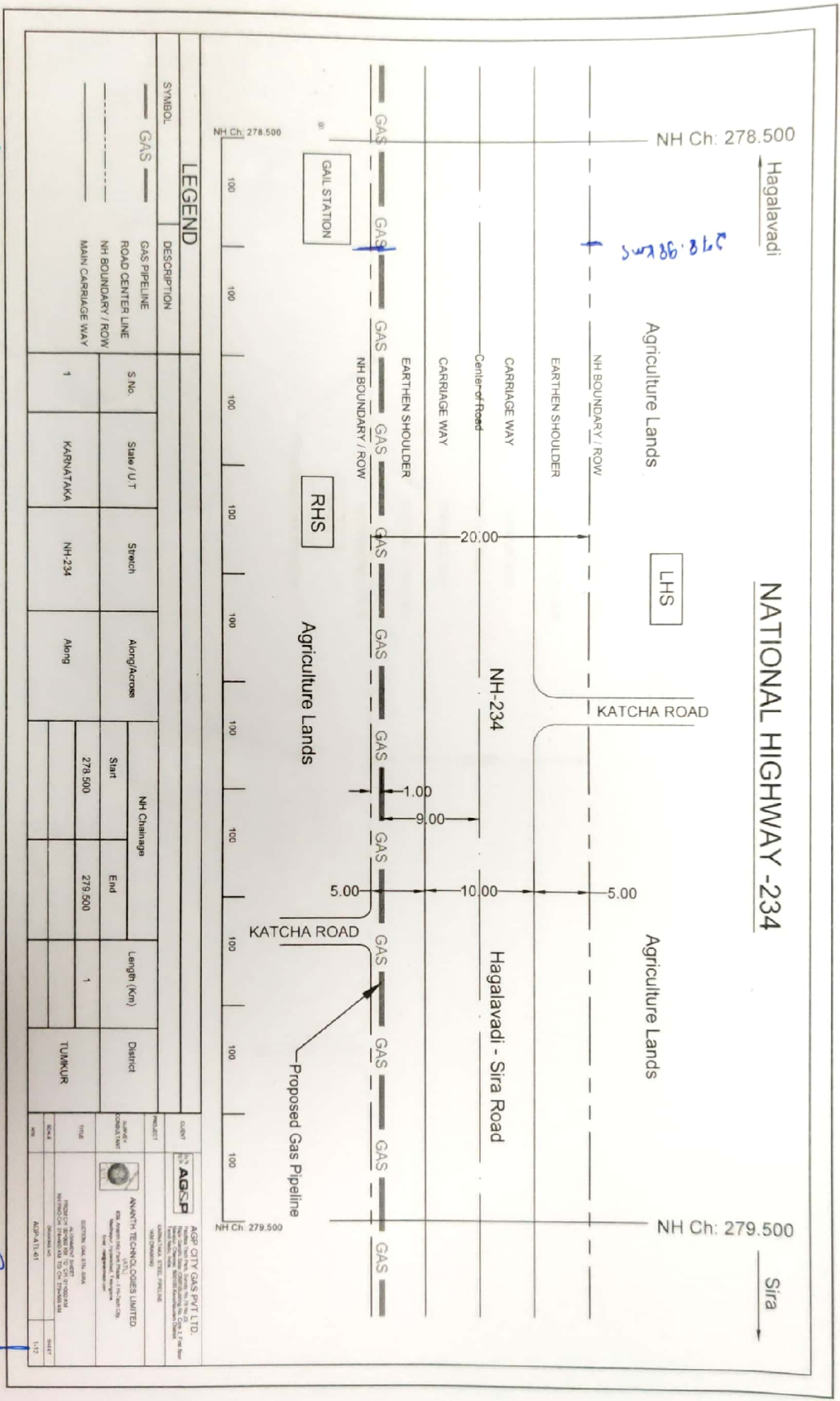

4. During laying of gas pipe line besides the ROW of NH-234(Huliyar-Sira section) if crosses any cross road, after laying gas pipe line make the cross road to its original position for smooth flow of traffic.
 5. During laying of gas pipe line make proper arrangements for safety and free flow of traffic under the guidance of police.
 6. Proposed for HDD method from Km.288.800 to Km. 290.200, at built up area and road crossings.
