Invitation of public comments

Sub:- Proposal for permission to laying 750 mm to 200mm DI and 160mm PVC pipe between Km.284/872 (Vikram Sarabhai road) and 286/610 (Kundannoor Junction) on NH 85 (Madura-Kochi road) By Kerala Water Authority in Ernakulam district Under NH Division Muvattupuzha in the State of Kerala.

The proposal is seeking permission for laying 750mm to 200mm DI and 160mm PVC pipe along the road between Km.284/872 (Vikram Sarabhai road) and 286/610 (Kundannoor Junction) on NH-85(Kochi-Madurai Road) by Kerala Water Authority, W.S Sub Division, Tripunithura submitted to this office vide EE, PWD NH division, Muvattupuzha's letter dated 27.09.2019 in accordance with Ministry's latest guidelines dated 22.11.2016. The proposal has been examined based on additional details furnished by the Assistant Executive Engineer, KWA, W.S Sub Division, Tripunithura vide letter dated 30.10.2019.

2. The proposal for laying 750mm to 200mm DI and 160mm PVC pipe along the road between Km.284/872 (Vikram Sarabhai road) and 286/610 (Kundannoor Junction) on NH-85(Kochi-Madurai Road) as under:

3. The Assistant Executive Engineer, KWA, W.S Sub Division, Tripunithura has proposed for laying 750mm to 200mm DI and 160mm PVC pipe in between Km.284/872 (Vikram Sarabhai road) and 286/610 (Kundannoor Junction) (RHS) and Km.284/993 to 286/610 (LHS) on NH-85(Kochi-Madurai Road) by Open Trench method.

4. The Assistant Executive Engineer, KWA, W.S Sub Division, Tripunithura has furnished an undertaking that, they will shift the utility at their own cost if required for expansion of reach by MORTH/PWD or any other Highways authorities within the time frame prescribed by MORTH/PWD. Further, it is also mentioned by the Assistant Executive Engineer, KWA, W.S Sub Division, Tripunithura that the proposed pipe line work will not affect the design, stability, traffic safety and future improvement of proposed stretch.

In addition, all the undertakings as prescribed in the checklist has been furnished by the Assistant Executive Engineer, KWA, W.S Sub Division, Tripunithura.


