(c) has held at least twenty five years' regular service in Group 'A' posts in the pay band-3 with pay scale of Rs.15600-39100/- plus grade pay of Rs.5400/- (6th CPC) /level 10 of pay matrix under 7th CPC and above out of which at least one year' regular service should be in the Senior Administrative Grade pay band-4 with pay scale of Rs.37400-67000/- plus grade pay of Rs.10000/-(6th CPC)/ level 14 of pay matrix under 7th CPC; and

(II) having eighteen years' experience in the field of Highway Engineering related to implementation of the projects.

(3) *A Member shall hold office for a term of three years from the date on which he enters upon his office and shall be eligible for re-appointment for a further term of two years, which may be extended for a further period of two years: provided further that no member shall hold office after he attains the age of sixty-four years. Notwithstanding anything contained in these rules, a Member shall hold office at the pleasure of the Central Government.*
