Corrigendum

Ministry of Road Transport & Highways vide advertisement issued in the Employment News on 22.12.2018 had advertised for filling up of the post of Member (Project) in NHAI. In continuation and partial modification of said advertisement, applications are invited from eligible candidates for filling up of one post of Member (Project) in the (pre-revised) pay scale of Rs. 67,000-79,000/- (6<sup>th</sup> CPC) / Level 15 as per 7<sup>th</sup> CPC in the National Highways Authority of India (NHAI), a statutory body under the Ministry entrusted with the task of implementation of National Highways Projects.

(2) The qualifications and experience required for the post of Member (Project) are as follows:-

A person shall not be qualified for appointment as a Member (Project) unless he-

- i) Has degree in Civil Engineering; and
- ii) Is employed in the Central Government or a State Government or Public Sector Undertaking or an autonomous body established under law for the time being in force; and
- iii) (I) (a) Is holding an analogous post in Higher Administrative Grade in the pay scale of Rs.67000-79000/- (6<sup>th</sup> CPC) at level 15 of the pay matrix as per 7<sup>th</sup> CPC; or  
(b) has at least three years' regular service in the Senior Administrative Grade of pay band-4 with pay scale of Rs.37400/---67000/- plus grade pay of Rs.10000/- (6<sup>th</sup> CPC) at level 14 of the pay matrix as per 7<sup>th</sup> CPC; or  
(c) has held at least twenty-five years' regular service in Group 'A' posts in the pay band-3 with pay scale of Rs.15600-39100/- plus grade pay of Rs.5400/- (6<sup>th</sup> CPC) at level 10 of the pay matrix as per 7<sup>th</sup> CPC and above out of which at least one year' regular service should be in the Senior Administrative Grade pay band-4 with pay scale of Rs.37400-67000/- plus grade pay of Rs.10000/- (6<sup>th</sup> CPC) at level 14 of the pay matrix as per 7<sup>th</sup> CPC; and

- (II) having eighteen years' experience in the field of the Highway Engineering related to implementation of the projects.
- (3) A member shall hold office as such for a term of three years from the date on which he enters upon his office and shall be eligible for re-appointment for a further term of two years: provided further that no member shall hold office as such after he has attained the age of sixty-two years. Notwithstanding anything contained in these rules a Member shall hold office at the pleasure of the Central Government.
- (4) The applications of only such officers / candidates will be considered that are routed through proper channel and are accompanied with following certificates: -
- i) Application in duplicate as per proforma given in the Annexure
  - ii) Cadre Clearance Certificate
  - iii) Statement giving the details of Major or Minor penalties imposed upon the officer, if any, during the last ten (10) years.
  - iv) Vigilance clearance
  - v) Integrity Certificate
  - vi) Attested copies of ACRs / APAR for the past five years.
- (5) Applications from eligible officers complete in all respect may be forwarded to Shri Rajesh Gupta, Deputy Secretary (Establishment), Ministry of Road Transport & Highways, Room No. 103, Transport Bhawan, 1, Parliament Street, New Delhi-110001 by 5.00 pm within fifteen days from the date of publication of this Advertisement (i.e. 03.04.2019). No advertisement is being published in the Employment News. It is also made clear that the selected candidates shall not be permitted to withdraw their candidature after submission of the applications.
- (6) All those who have applied in response to the earlier advertisement and fulfil the above mentioned qualifications for the post of Member (Project) in National Highway Authority of India need not apply again.
- (7) Incomplete application/applications submitted to any officer other than the designated officer i.e. Deputy Secretary (Estt.) and those received after the prescribed date/time shall be summarily rejected.
