## Corrigendum

Ministry of Road Transport & Highways vide advertisement issued in the Employment News on 22.12.2018 had advertised for filling up of the post of Member (Project) in NHAI. (2) The qualifications and experience required for the post of Member (Project) are as follows:-

A person shall not be qualified for appointment as a Member (Project) unless he-

- Has degree in Civil Engineering; and
- ii) Is employed in the Central Government or a State Government or Public Sector Undertaking or an autonomous body established under law for the time being in force; and
- iii) (I) (a) Is holding an analogous post in Higher Administrative Grade in the pay scale of Rs.67000-79000/-(6<sup>th</sup> CPC) at level 15 of the pay matrix as per 7<sup>th</sup> CPC; or

(b) has at least three years' regular service in the Senior Administrative Grade of pay band-4 with pay scale of Rs.37400/-67000/- plus grade pay of Rs. $10000/-(6^{th} CPC)$  at level 14 of the pay matrix as per  $7^{th}$  CPC; or

(c) has held at least twenty-five years' regular service in Group 'A' posts in the pay band-3 with pay scale of Rs.15600-39100/- plus grade pay of Rs.5400/-( $6^{th}$  CPC) at level 10 of the pay matrix as per 7<sup>th</sup> CPC and above out of which at least oneyear' regular service should be in the Senior Administrative Grade pay band-4 with pay scale of Rs.37400-67000/- plus grade pay of Rs.10000/-( $6^{th}$  CPC) at level 14 of the pay matrix as per 7<sup>th</sup> CPC; and

(II) having eighteen years' experience in the field of the Highway Engineering related to implementation of the projects.

(3) A member shall hold office as such for a term of three years from the date on which he enters upon his office and shall be eligible for re-appointment for a further term of two years: provided further that no member shall hold office as such after he has attained the age of sixty-two years. Notwithstanding anything contained in these rules a Member shall hold office at the pleasure of the Central Government.

(4) The applications of only such officers / candidates will be considered that are routed through proper channel and are accompanied with following certificates: -

i) Application in duplicate as per proforma given in the Annexure

ii) Cadre Clearance Certificate

iii) Statement giving the details of Major or Minor penalties imposed upon the officer, if any, during the last ten (10) years.

iv) Vigilance clearance

v) Integrity Certificate
