Applications are invited from eligible candidates for filling up of one post of Member (Project) & Member (Tech.) in the (pre-revised) pay scale of Rs. 67,000-79,000/- (6th CPC) / Level 15 as per 7th CPC in the National Highways Authority of India (NHAI), a statutory body under the Ministry entrusted with the task of implementation of National Highways Projects.

(2) The qualifications and experiences required for the post of Member (Project) & Member (Tech.) are as follows:-

A person shall not be qualified for appointment as a Member (Project) & Member (Tech.) unless he/she:-

- (i) has degree in Civil Engineering; and
- (ii) Is employed in the Central Government or a State Government or Public Sector Undertaking or an autonomous body established under law for the time being in force; and
- (iii) (I) (a) is holding an analogous post in Higher Administrative Grade in the pay scale of Rs.67000- 79000(6th CPC) / level 15 of pay matrix under 7th CPC;-
or
(b) has at least three years' regular service in the Senior Administrative Grade of pay band-4 with pay scale of Rs.37400-67000/- plus grade pay of Rs.10000/- (6th CPC)/ level 14 of pay matrix under 7th CPC; or
(c) has held at least twenty five years' regular service in Group 'A' posts in the pay band-3 with pay scale of Rs.15600-39100/- plus grade pay of Rs.5400/- (6th CPC) /level 10 of pay matrix under 7th CPC and above out of which at least one year' regular service should be in the Senior Administrative Grade pay band-4 with pay scale of Rs.37400-67000/- plus grade pay of Rs.10000/- (6th CPC)/ level 14 of pay matrix under 7th CPC; and
(II) having eighteen years' experience in the field of Highway Engineering related to implementation of the projects.

(3) A member shall hold office as such for a term of three years from the date on which he/she enters upon his office and shall be eligible for re-appointment for a further terms of two years: provided further that no member shall hold office as such after he/she has attained the age of sixty-two years. Notwithstanding anything contained in these rules a Member shall hold office at the pleasure of the Central Government.

(4) The applications of only such officers / candidates will be considered that are routed through proper channel and are accompanied with following certificates:-

- i) Application in duplicate as per proforma given in the Annexure
- ii) Cadre Clearance Certificate
- iii) Statement giving the details of Major or Minor penalties imposed upon the officer, if any, during the last ten (10) years.
- iv) Vigilance clearance
- v) Integrity Certificate
- vi) Attested copies of ACRs / APAR for the past five years.
