- **5.3.2 TA/DA:** No TA/DA shall be admissible for joining the agreement or on its completion. Foreign travel of Consultant permitted only, in exculpation cases. However, Consultant shall be allowed TA/DA for their travel inside the country in connection with the officer work after approval of the competent authority.

- **5.3.3** Tax Deduction at Source (TDS): TDS as admission shall be deducted from the monthly remuneration of Consultants. A TDS certificate shall be issued by the concerned DDO on demand.
- **6. WORKING HOURS:** Consultant may follow the normal working hours as prescribed (i.e. from 9:00 AM to 5:30 PM). However, as per exigency, one has to sit late to complete the time-bound work without extra remuneration.
