Invitation of public comments

Subject: Permission for laying underground water supply pipeline along the National Highways from Km 305/712 to Km 306/072, Km 310/877 to Km 312/183 (LHS), Km 305/972 to Km 308/963 (RHS), Km 312/183 to Km 312/395(RHS) and acrossing at Km 305/972, Km 307/750, Km 308/963, Km 310/877 and Km 312/183 (Bengalure-Kanakapura-Malvalli-Chamraj Nagar-Sathy-Coimbatore Road) of NH-948 in the State of Tamil Nadu - Regarding.

2. The proposal is regarding permission for laying underground water supply pipeline along the National Highways from Km 305/712 to Km 306/072, Km 310/877 to Km 312/183 (LHS), Km 305/972 to Km 308/963 (RHS), Km 312/183 to Km 312/395(RHS) and acrossing at Km 305/972, Km 307/750 & Km 308/963, Km 310/877 and Km 312/183 (Bengalure-Kanakapura-Malvalli-Chamraj Nagar-Sathy-Coimbatore Road) of NH-948 in the State of Tamil Nadu was submitted to this office by the SE, NH Salem vide letter No.2455/2019/JDO/NH dated 08.08.2019 (received on 20.11.2019) has submitted the proposal to this office in accordance with Ministry's latest guidelines dated 22.11.2016.

3. The alignment proposed by Executive Engineer, TWAD Board, RWS Division, Coimbatore is to lay the underground water supply pipeline along the National Highways from Km 305/712 to Km 306/072, Km 310/877 to Km 312/183(LHS), Km 305/972 to Km 308/963 (RHS), Km 312/183 to Km 312/395(RHS) and acrossing at Km 305/972, Km 307/750 & Km 308/963, Km 310/877 and Km 312/183 (Bengalure-Kanakapura-Malvalli-Chamraj Nagar-Sathy-Coimbatore Road) of NH-948 i.e. in a length of 4869m as detailed under:

4. The right of way is Varies 17m to 35.50m in the aforesaid stretch. The Executive Engineer, TWAD Board, RWS Division, Coimbatore has proposed to lay the underground water supply pipeline at the stretch in a length of 4869m. However, in the entire length of 4869m the underground water supply pipeline is proposed to be laid at a distance less than 15m which is not in conformity with Ministry's guidelines vide letter No.NH-III/P/66/76 dated 19.11.1976. Further Executive Engineer, TWAD Board, RWS Division, Coimbatore has proposed to lay the water pipeline along the NH by Trench Method & across the NH by Trenchless Method and proposed the lay pipeline across the NH by HDD method at a depth of 1.050m from the bottom of the road.


5. The Executive Engineer, TWAD Board, RWS Division, Coimbatore underground water supply pipeline has furnished an undertaking to the effect that TWAD will remove the laid underground water supply pipeline line in future if required by NH wing of State Highways Department/ MoRTH Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH Govt. of India and any right on the NH land. Further, mentioned that TWAD will also restore the surfaces to its original condition soon after removal of the underground water supply pipeline. Also, certificated that the proposed underground water supply pipeline work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

6. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 the relaxation application will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
